Participant would like to engage in fishing, hiking, horseback riding, all-terrain or utility terrain vehicle (“ATV”) driving and riding, shooting, archery and/or other recreational activities (the “Activities”) based at or near the Fish On Ranch, LLC (the “Ranch”), including trips to, from and in the vicinity of the ranch in Centennial, Albany County, Wyoming.

Participant understands that the Activities involve substantial risks of injury to the individuals engaging in the Activities and to property. The Ranch will only furnish services and access to the Activities on the terms set forth below, whereby Participant expressly agrees and promises to fully accept and assume all of the risks existing in the Activities including all injuries and damages, rather than the Ranch. The Activities are voluntary and will only be done on these terms. Therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Participant hereby voluntarily releases, forever discharges, indemnifies and agrees to defend and hold harmless the Ranch, its owners, officers, directors, members, managers, employees, agents, volunteers participants, supervisors and affiliates from and against any and all claims, demands and liabilities against any and all claims, demands and liabilities, known or unknown, against any of them, and related expenses (including reasonable attorneys’ fees) directly or indirectly relating to or in any way connected with Participant’s participation in any and all Activities, the use of Ranch’s equipment, animals or facilities, including any such claims which allege acts or omissions of the Ranch.

Participant certifies that he/she has adequate insurance to cover any injury or damage he/she may cause or suffer while on the Ranch or while participating in the Activities. Participant agrees to bear the costs of any injury or damage to himself/herself. Participant further certifies that he/she has no medical or physical condition which could interfere with his/her safety and Participant is willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.

Participant has been advised to wear a helmet at all times when mounted on a horse and that he/she is required to wear a helmet at all times when operating or riding on an ATV. Participant acknowledges that a helmet has been made available. In the event Participant rejects your advice and rides without a helmet, Participant understands that he/she is increasing the risk of injury. Participant understands how to operate the ATV and agrees to operate it safely and in accordance with all traffic rules and regulations and in a manner that does not unreasonably disturb the land, wildlife, livestock or vegetative resources. Participant agrees to pay for all damage to any ATV in Participant’s possession regardless of the circumstances under which such damage may occur; to pay for lost rental income for the period of time the ATV is out of service due to such damage; and to pay all costs (including reasonable attorneys’ fees) incurred by the Ranch to collect any sums due from Participant or to enforce the terms of this agreement.

Participant grants Fish On Ranch, LLC to use his/her likeness in photo or otherwise for promotional and marketing purposes without payment, royalties or other consideration, and acknowledges such materials shall become the property of the Ranch. Participant irrevocably authorizes the Ranch to edit, alter, copy, exhibit, publish or distribute these materials for any lawful purpose.

This agreement shall remain in full force and effect so long as the Ranch provides any Activities and the indemnity set forth herein shall remain in full force and effect as to any later claims relating to Activities. This agreement is not assignable by Participant and may not be unilaterally cancelled or modified except in writing signed by both parties. This agreement is binding on Participant’s successors, assigns, heirs, estates and personal representatives. This is a valid and binding agreement that has been properly entered into by Participant. This agreement is governed by Wyoming law and any disputes hereunder shall be resolved in the Second Judicial District Court in and for Albany County, Wyoming.
